• Business Manager, Sara Sarensen reported that April and May will show more revenue than the previous year. This is because the ESD is behind on state school fund payments because of the change in the taxes this year. The tax revenue for the year is down and ODE will be adjusting this in May.

- District 7 is doing operation prom night. This is a simulation of what could happen from drinking and driving. The ESD School Response Team (SRT) will be at the high school to assist any kids who may need emotional support.
- Behavior Specialist, Kylie Hickey had her baby at the end of March.
- The Youth Mentor Program held their annual fundraiser and were able to raise \$8,000. Jim Hiatt donated a horse from the Beatty Butte Wild Horse Organization.
- Jack has been in contact with the contract SLP, Kaitlin to help her arrange her stay in Lake County.

2022-23 STAFF COLA AND INSURANCE CAP

The ESD staff would like to request that the Board approve a 4% COLA and \$15 insurance cap increase. Based on current staffing combined with projections for two new hires (Supt & School Psych), this request will cost approximately \$49,385, split almost exactly 50/50 between the General Fund and Special Funds. Preliminary budget estimates for next year show that our budget can come within \$12,000 of covering this cost. There are still some unknown expenses at this time, such as the actual cost of a new accounting assistant, and how much revenue might be generated by charging administrative fees on some of our special funds.

INTERGOVERNMENTAL AGREEMENT

Superintendent Thompson has created an intergovernmental agreement between Lake County ESD and Plush School District #18. This agreement explains the guidelines of which the superintendent would follow and act upon for the Plush School District. With the ESD board approval, Jack will present this to the Plush School District Board. If the Plush Board does not agree upon the terms of the agreement, the ESD will provide no administrative services.

AUDIT CONTRACTS

Business Manager, Sara Sarensen put out RFP's for an auditing contractor for the 2022-23 year. There were two responses, Umpqua Valley Financial and KDP. Umpqua Valley Financial has been the audit firm for the last three years. The general census is that the county is happy with Umpqua and would like to continue with them. District 7 would like to contract with KDP due to issues during the current year audit. Michael Carter stated that the District 7 would pick up the \$24,000 difference. The ESD, North Lake, Plush, Paisley and Adel will continue with Umpqua Valley Financial.
