#### **SUPERINTENDENT REPORT (LANE STRATTON)**

- The ESD staff will be doing a St. Patrick's Day luncheon next Thursday and Friday including corned beef and cabbage, potatoes and carrots.
- The Integrated Guidance application opened this week. Lane and Mark hosted the two other superintendents, their business managers, and ODE to get them going on the process.
- Mark Louie will be exchanging some of his spring break days to help assist Paisley with the application.
- The SSPS grant is still under question if this is a one-time grant or will be a an on going grant.
   Superintendent Stratton is considering contracting through Malheur ESD to use their current SSPS person.
- There is roughly \$5,000 left in the retention and recruitment grant that Lane is trying to find ways

to spend.

- Lane is noticing through conversations with the specialists there is an ever growing increasing in special education kiddos.
- Supt. Stratton made the board aware that he hosts monthly sped staff and regular staff meetings.
- There are expected to be three staff members who will be on maternity leave next year. We are working on establishing a mother's expressing room.
- Supt. Stratton worked on certified staff observations. Lane noticed the rubric the ESD has used
  in previous years isn't the best rubric and he wants to reach out to other ESDs to see what they
  use.
- District 7 has continued to ask for more sped services but has been more specific and requested that Alina be in the "nest" room two times a week as the special education teacher. This is a change in the prior request of having Alina at Union for more time.
- Lane explained that the Early Learning Hub is trying to promote baby showers for the families of Lake County to gift them with baby things as well as resources for them. Lane is hoping that the ESD would be able to help build baskets for these families.
- Plush and Adel had their building reviews done by High Dessert ESD. This report is for school use and information only.
- Lane is working on getting the school districts fentanyl training.
- "I am not a therapist, I am a teacher" training scheduled for Monday, August 28th for all districts.
- Rosana Cahill will begin working with the preschoolers in Adel.
- The ESD program survey has begun circulating.
- Lane mentioned two senate bills that are catching attention: SB 49 and SB 584.
